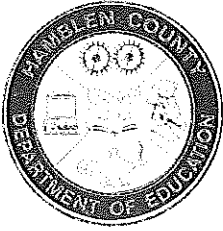

The Hamblen County Board of Education formally expresses appreciation for the Hamblen County Commission's and County Mayor's support of the school system. The Board of Education understands that the Commission has demonstrated a level of support for our capital building program but that there may be some concerns about specific elements of the program. The Hamblen County Board of Education and the Office of the Superintendent are firmly committed to the following:

First, we fully understand that we serve the citizens of Hamblen County and that a significant portion of the tax revenue is already allocated to our school system. We are highly committed to being good stewards of all monies appropriated to the school system, and we will be vigilant in our efforts to spend all revenue in an appropriate and prudent manner.

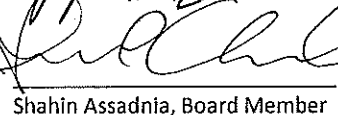
Second, it is our firm belief that any major capital building project is a joint partnership between the Board of Education and the County Commission. It is essential that the superintendent maintain consistent communication with the Commission and Mayor; therefore, the superintendent will provide a monthly update to the Commission/Mayor on all capital building programs and will answer any questions or concerns the Commission/Mayor may have. The entire process from the development of bid specifications to the ribbon cutting will be open, honest, and transparent. The Commission/Mayor will clearly know the scope of the project, what is included in the original bid, and what constitutes the final project.

Third, each update will contain specific information to help keep the Commission/Mayor informed. The superintendent will provide an update on the schedule of work, a description of any significant issues or concerns, an analysis of the draw-down schedule (how much money has been spent each month), and any change orders which may become necessary.

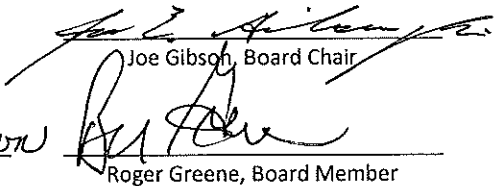
Fourth, the superintendent will do all he can to ensure that accurate cost estimates are obtained before the project is approved. This will enable the Commission/Mayor to more effectively plan and budget. However, the superintendent will keep the Commission/Mayor informed throughout the process of any potential deficits or surpluses. All efforts will be made to ensure that the project is completed within budget and there is no need for additional financial requests. It is the job of the superintendent to ensure that there are no deficits. Conversely, the superintendent will notify the Commission/Mayor if there will be a surplus. The superintendent will constantly monitor the process to bring the project under budget through value-engineering, careful planning, and supervision. The superintendent will not expand the scope of work, reallocate any surplus money to other projects, or modify the original project in any manner to expend surplus money. All surplus money will be returned to the Commission unless the Board of Education and the County Commission mutually agree to use any surplus money for additional projects that are legitimate and legally allowed.

Finally, the superintendent will make himself readily available to the Commission/Mayor for any questions, concerns, or updates that are required or requested. It is the responsibility of the superintendent to serve and to keep both the Commission and the Board of Education informed.

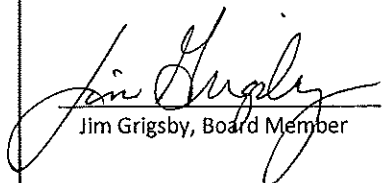

County Mayor Executive Assistant

Nature of Work

This is a very responsible administrative work providing assistance to the County Mayor in a variety of matters and assisting with the coordination of County Commission activities and related functions for Hamblen County. Activities associated with the job include coordinating and scheduling all County Commission and related committee meetings and ensuring the availability of space, running public notices and preparing agendas for County Commission and committee meetings and ensuring they are distributed in a timely manner, and receiving, logging and distributing videos of County Commission meetings. Additional activities include preparing correspondence, resolutions and proclamations, maintaining files of correspondence for the County Mayor and interacting with numerous county offices, local boards and agencies, and councils to provide information and assistance. Job related duties require considerable experience performing administrative functions and working with the public preferably in a governmental setting, strong organizational, interpersonal and decision making skills, dedicated attention to detail and considerable knowledge of county government departments, fees offices and related functions. Job performance is evaluated by the County Mayor through review of the organization and coordination of office functions, efficiency and thoroughness of administrative duties, level of administrative support provided for the Mayor's office, organizational and decision making skills and ability to work successfully with local officials, co-workers and the public.

Illustrative Examples of Work

- Schedules and coordinates meetings for the County Mayor including scheduling dates, making the necessary accommodations, providing refreshments when necessary, etc.

- Considerable knowledge of county government offices, functions, interactions and responsibilities.
- Considerable knowledge of county procurement and purchasing procedures.
- Considerable knowledge of contemporary office administration and organization.
- Considerable knowledge of commonly accepted grammatical form and practice utilized for correspondence, memoranda, reports, etc.
- Considerable knowledge of computer hardware components and software programs including data base management, word processing and spreadsheet applications.
