RESOLUTION 21-

RESOLUTION TO ADOPT A REAPPORTIONMENT/REDISTRICTING PLAN FOR HAMBLEN COUNTY

WHEREAS, *Tennessee Code Annotated*, Section §5-1-111, requires that, at least every ten (10) years, county legislative bodies shall change the boundaries of districts or redistrict a county entirely if necessary to apportion the county legislative body so that the members represent substantially equal populations; and

WHEREAS, Hamblen County has prepared a plan consistent with the provisions of *Tennessee Code Annotated*, Section §5-1-111, which provides for a county legislative body, composed of 14 members and which created 14 districts as depicted on the official redistricting map for Hamblen County prepared pursuant to *Tennessee Code Annotated*, Section §5-1-110.

NOW,THEREFORE, BE IT RESOLVED by the Hamblen County Legislative Body meeting in regular session at Hamblen County, Tennessee on this <u>21st</u> day of <u>October</u>, <u>2021</u>, that;

SECTION 1. There is hereby adopted a reapportionment plan for Hamblen County which provides for <u>1</u> commissioner(s) in each of the <u>14</u> districts for a total county legislative body of <u>14</u> members. The districts for members of the county legislative body are depicted on the official redistricting may for Hamblen County prepared pursuant to *Tennessee Code Annotated*, Section §5-1-110. A copy of the redistricting map is attached as <u>Exhibit A</u> to this resolution and is incorporated herein by reference.

SECTION 2. All members of the county legislative body shall be elected at large within the district wherein the candidate seeks election.

SECTION 3. The plan shall take effect upon passage, the public welfare requiring it, provided that vacancies shall be filed in accordance with *Tennessee Code Annotated*, Section § 5-1-104.
