IMPOUND LOT USE AGREEMENT

This Impound Lot Use Agreement ("Agreement") is entered into this _____ day of _____ 2021 by and between THE CITY OF MORRISTOWN, TENNESSEE ("City") and HAMBLEN COUNTY, TENNESSEE, ("County").

WITNESSETH

Whereas, the City owns and currently operates and uses an impound lot, known as the Roy Widener Impound Lot ("Impound Lot"), located at 619 North Liberty Hill Road, Morristown, Tennessee 37184, and

Whereas, the City has moved vehicles it was storing off of the Impound Lot and has agreed to allow the County to utilize this Impound Lot while the County Justice Center project is being completed, and

Whereas, the City and County do hereby intend to enter into this Impound Lot Use Agreement to provide for the County's use of this Impound Lot.

NOW THEREFORE IT IS AGREED AS FOLLOWS:

- 1. <u>Impound Lot Use</u>. The County shall be permitted to use the Impound Lot to store vehicles and other items during the construction of the County Justice Center. During this use and the term of this Agreement, the County does agree to maintain this Impound Lot as stated further herein.
- 2. <u>Term of Agreement</u>. The initial term of this Agreement shall run from January 1, 2022 until such time as the County Justice Center is completed. After the initial term, the parties may agree to continue to operate under this Agreement on a biannual basis.
- 3. <u>Insurance & Indemnification</u>. To the extent permitted by law, the County agrees to defend, indemnify and hold City harmless from any and all claims, losses, costs, expenses, or damages arising from the County's use of the Impound Lot. Furthermore, the County agrees to maintain general liability insurance insuring against liability for bodily injury, death or damage to personal property with combined single limits of one million dollars (\$1,000,000). In addition, the County agrees to maintain worker's compensation in statutory amounts, employer's liability insurance with combined single limits of one million dollars (\$1,000,000), automobile liability insurance insuring against claims for bodily injury or property

damage with combined single limits of one million dollars (\$1,000,000), and all risk property insurance covering all personal property for full replacement value. The required insurance shall be in place for the duration of this Agreement.

- 4. <u>Utilities & Security</u>. County shall be solely responsible for the utilities and security expenses associated with the Impound Lot. The parties shall coordinate the transfer of these accounts into the County's name and the County shall begin paying these fees effective January 1, 2022.
- 5. <u>Usage Fee</u>. For the use of the Impound Lot, County shall pay the City five thousand dollars (\$5,000.00) per year, said payment to be paid bi-annually, with twenty-five hundred dollars (\$2,500.00) due on January 31st of each year and twenty-five hundred dollars (\$2,500.00) due on July 31st of each year.
- 6. <u>**Binding Effect</u>**. This Contract and Agreement shall be binding upon the undersigned, their successors and assigns unless modified by an agreement in writing executed by the parties hereto.</u>
- 7. **Disputes**. Should any disputes arise between the parties, Tennessee law shall govern and venue shall lie in Hamblen County, Tennessee.
- 8. <u>Termination</u>. Each party reserves the right to terminate this Agreement at any time upon providing thirty (30) days written notice. Upon the termination and/or conclusion of this Agreement, the County agrees to remove all vehicles and items being stored on the Impound Lot and to restore the property to the condition it was in prior to entering into this Agreement. Additionally, the City shall reimburse the County the pro-rated amount of the usage fee based on when the Agreement is terminated.

A JOINT RESOLUTION OF THE COUNTY LEGISLATIVE BODY OF HAMBLEN COUNTY, TENNESSEE AND THE CITY OF MORRISTOWN, TENNESSEE REQUESTING THE STATE OF TENNESSEE TO KEEP THE SWIMMING POOL AT PANTHER CREEK STATE PARK OPEN

WHEREAS, Panther Creek State Park is one of 56 state parks in Tennessee that attract millions of visitors from throughout the United States every year to enjoy hiking, camping, boating, swimming and many other outdoor activities; and,

WHEREAS, state parks play a key role in making tourism the third leading industry in Tennessee generating millions of dollars' worth of economic activity for their communities; and,

WHEREAS, the swimming pool at Panther Creek State Park has offered park visitors and the Lakeway Region a public place to swim with family and friends and to enjoy other park amenities for 36 years and is the only public pool in operation in Hamblen County ; and,

WHEREAS, the Tennessee Department of Environment and Conservation (TDEC) announced in December 2021 its plans to close the swimming pools at 11 state parks including the one at Panther Creek State Park citing declining usage, cost to repair the pools and cost of operation for a seasonal activity; and

WHEREAS, many park patrons, such as members of Friends of Panther Creek State Park, and local leaders disagree with the state's decision and want state officials to consider options to keep the pool open because of its value to park visitors and the community;

NOW THEREFORE, BE IT RESOLVED by the members of the Hamblen County Commission and Morristown City Council, with the support of State Representative Rick Eldridge and State Senator Steve Southerland, that Tennessee state park officials reverse their decision to close the pool at Panther Creek State Park and choose to keep it open with possible changes to its operation to make it more accessible for public use.

BE IT FURTHER RESOLVED that certified copies of this resolution are mailed to the offices of Governor Bill Lee, TDEC Commissioner David Salyers and Deputy Commissioner for Parks and Conservation Jim Bryson.

The mayors of Morristown and Hamblen County announced today plans to introduce a joint resolution to their legislative bodies strongly urging the State of Tennessee to reverse its decision to close the swimming pool at Panther Creek State Park and to start discussions with local leaders about other options.

The state's Parks and Conservation Bureau announced in December plans to close the swimming pools at 11 state parks, including the pool at Panther Creek State Park. Hamblen County Mayor Bill Brittain said the decision was made without input for local elected officials or park supporters.

"The swimming pool at the park is the last public pool in operation in Hamblen County," Brittain said. "It attracts about 9,000 visitors a year and is a significant attraction during the summer months. We want state parks officials to keep the pool open and lengthen its season so it will get more use."

The swimming pool at the park has been closed the last two summers because of the COVID pandemic, and state officials say it needs repairs that will cost about \$580,000. They say it also costs about \$45,000 more to operate than it generates in revenue each season.

"The park's swimming pool is a valuable asset for our community," Morristown Mayor Gary Chesney said. "The state announced recently that it has more than a billion dollars in reserves so they should use some of the money to make the repairs and keep the pool in operation."

State parks officials have allocated \$400,000 to develop another swimming option using Cherokee Lake or to develop other recreation options. Public input is currently being solicited by the Parks and Conservation Bureau.

The Park is located within Hamblen County Commissioner Eileen Arnwine's district. "The state park attracts visitors from several states as well as throughout East Tennessee," she said. "The pool needs to stay open to continue generating tourism related business for our county."

The mayors said the joint resolution will be presented the Morristown City Council and Hamblen County Commission during their January meetings and sent to Governor Bill Lee and the state parks commissioner after it's adopted.

TENNESSEE STATE PARKS TO INVEST FUNDS, SEEK VISITOR INPUT AT 5 AREA PARKS FOR YEAR-ROUND OUTDOOR RECREATION OPTIONS

NASHVILLE – Tennessee State Parks will seek input from visitors of five parks in Upper East Tennessee in meetings beginning Dec. 13 to discuss replacement options for swimming pools currently at those parks.

Parks officials announced that swimming pools will not reopen at David Crockett Birthplace State Park, Roan Mountain State Park, Warriors' Path State Park, Panther Creek State Park and Cove Lake State Park. The swimming pools were closed in 2020 and 2021 due to complications related to COVID-19. Reopening the pools is unfeasible due to aging facilities, declining visitation pre-COVID 19 and high expenses. Tennessee State Parks has allocated \$400,000 for each park to invest in new outdoor recreation activities. State parks officials encourage Tennesseans to voice their opinions on options for alternative, year-round outdoor recreational operations at each park.

"The swimming pools at these parks require major maintenance upgrades while usage continues to decline. We believe it is unfair to Tennessee taxpayers for the state to continue to invest in these swimming pools with rising costs and declining visitation," Jim Bryson, deputy commissioner of the Tennessee Department of Environment and Conservation, said. "Fortunately, the Tennessee General Assembly has been very supportive of the parks in recent years, which has allowed us to allocate funding for options that are more fiscally responsible to taxpayers and that visitors can enjoy year-round. We first want to hear from visitors of the parks about what they would prefer and use."

The funds for each park will go to options that can be used throughout the year. Swimming pools, in contrast, operate only 70 days each year.

At David Crockett Birthplace State Park, the pool is 46 years old, and visitation is down.

At Roan Mountain State Park, the pool is 41 years old, and visitation is down.

At Warriors' Path State Park, the pool is 59 years old, visitation is down, a public pool exists nearby, and swimming in the lake is available.

At Panther Creek State Park, the pool is 36 years old, visitation is down, lake swimming opportunities exist, and a public splashpad is five miles away.

At Cove Lake State Park, the pool is 72 years old, and visitation is down.

Resolution Opposing the 2022 State House Redistricting Plan that Divides Hamblen County into Two House Districts

WHEREAS, every ten years, following the completion of the federal census, the Tennessee State Legislature must adopt a redistricting plan for the State House and the State Senate; and,

WHEREAS, population shifts from one census to the next often require changes of district boundaries so that the district population falls within the range established during the redistricting process; and,

WHEREAS, the proposed 2022 State House redistricting plan divides Hamblen County between District 10 and District 11 because the County's population falls about 5,000 people shy of the number needed to stay a state house district by itself; and,

WHEREAS, Hamblen County is a vibrant, growing community that serves as an economic hub for a 6-8 county area; and,

WHEREAS, Hamblen County deserves the attention and focus of one state representative who understands the uniqueness of its community;

NOW THEREFORE, BE IT RESOLVED, the members of the Hamblen County Legislative Body oppose the state house redistricting plan that divides the county between two districts and strongly encourages the state House leadership to redraw the redistricting plan to keep Hamblen County whole;

BE IT FURTHER RESOLVED that certified copies of this resolution be mailed to Governor Bill Lee, Speaker of the House Cameron Sexton and Majority Leader William Lamberth.

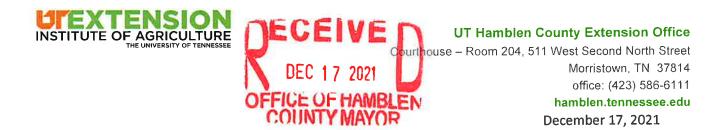
